## AMENDMENT TO RESTRICTIONS RECORDED IN OFFICIAL RECORDS BOOK 2943, PAGES 1333 ET SEQ., OF THE PUBLIC RECORDS OF CITRUS COUNTY, FLORIDA

WHEREAS, Hampton Hills, LLC, a Delaware limited liability company f/k/a Hampton Hills, a Florida General Partnership, is the developer of various parcels of real property made, or to be made, subject to the Declaration of Covenants, Conditions, Restrictions and Easements for Halls Reserve, recorded at O.R. Book 2943, Page 1333 et seq., et al., which properties are situated in Citrus County, Florida;

WHEREAS, Hampton Hills, LLC, the Developer, desires to amend the Declaration to make the changes set forth herein; and,

WHEREAS, Hampton Hills, LLC, the Developer, does hold title to sufficient property as required by the Declaration of Covenants and Restrictions for Halls Reserve in order to amend Covenants in accordance with Article VIII, Section 1;

Now, THEREFORE, Hampton Hills, LLC, by and through its authority granted by the Declaration, does hereby record this amendment to the Declaration to amend and restate in its entirety Section 5, of Article 7, as follows:

Animals. No animals, livestock or poultry of any kind shall be raised, bred, or kept in any Lot/Unit/Dwelling, except that not more than 2 common household pets, such as dogs, cats, birds, or any combination thereof, or any other domesticated pets may be kept, provided that they are not kept, bred or maintained for any commercial purpose or purposes. All pets must be kept on leashes and curbed when outside of the Owner's Lot, Unit, or Parcel. The Owner or other person harboring such pet shall be responsible for taking immediate sanitary procedures to clean and remove any feces of the pet from the Property. Any pet causing or creating a nuisance or unreasonable disturbance, including, without limitation, violating the foregoing sentence, may be removed from the Property upon three (3) days written notice by the Association to the Owner thereof or to the person harboring such pet. An Owner may receive a letter of approval from either the Declarant or the ACB, allowing Owner to have more than 2 domesticated pets.

In all other respects the restrictions are confirmed by the Developer, Hampton Hills, LLC.
